Governor Comments

Greetings ACP colleagues,

Summer is upon us and I hope everyone has plans to get away and recharge, at least for a short time. The downside of vacation? Coming back to a pile of emails, forms, and phone calls to clean up; if someone has a solution other than quitting, retiring or ignoring please share with the rest of us!

2016 has already seen its share of issues that impact internal medicine. Here are my top three, paying homage to the epic Clint Eastwood spaghetti western movie: The Good, the Bad, and the Ugly (in this case 'Uncertain').

The Good: The ABIM announced in early May plans to offer two options as part of the Maintenance of Certification (MOC) assessment starting in 2018: 1) The standard ten-year exam, which many have come to know and loathe, or 2) A shorter test taken at an office or home computer, perhaps annually or less frequent (details still being worked out). Physicians must perform well enough on the latter to opt out of the ten-year exam. Replacing this high-stakes test with a series of shorter assessments is one of several changes the ACP has been pushing the ABIM to make.

The Bad: Missouri Legislature's inability to establish a reasonable Prescription Drug Monitoring Program (PDMP). House Bill 1892 had overwhelming support by multiple groups including the Missouri ACP chapter; special thanks to **Steve Keithahn**, **MD**, **FACP** and the rest of our Health and Public Policy Committee for their efforts in Jefferson City. The bill made it to the Senate floor where Senator Robert Schaaf attached an amendment requiring a state-wide public vote, effectively killing any hope of passage this year. Once again Missouri remains the only state in America without a PDMP.

The Uncertain: The passage of the Medicare Access and CHIP Reauthorization Act (MACRA) in 2015 ushers in a new era of reimbursement *intended to align payment with value*. Will this be the case? The ACP believes MACRA has great potential, but how certain measures (clinical, meaningful use, practice improvement, etc.) are selected and reported will be critically important. Much work remains, and the ACP will labor on behalf of internal medicine to help the Centers of Medicare and Medicaid Services (CMS) and Congress get it right.

Aligning GME Financing with Workforce Needs

The Alliance for Academic Internal Medicine and ACP released a new policy paper calling for changes that better align funding for Graduate Medical Education (GME) with the nation's health care workforce needs. The paper, <u>Financing U.S. Graduate Medical Education</u>, was published in Annals of Internal Medicine on May 3.

Immediate Attention Required: Value Based Payments in 2019 will use 2017 data

Now is the time to act if you want to modify your practice for how you will be reimbursed in 2019. CMS has issued proposed regulations migrating Medicare to a quality reimbursement environment for physicians. MACRA (Medicare Access & CHIP Reauthorization Act of 2015), which repealed the SGR is creating new regulations related to PQRS, Meaningful Use, and the Value Based Modifier. They are all being rolled in MIPS (merit based incentive payment system) for those who choose not to participate in APMs (alternative payment models) which have more risk and therefore more upside potential. CMS has recognized smaller groups have fewer resources to accommodate significant change and has made available free assistance for physicians to comply with this rapidly evolving landscape. Save the Date: Updates in Internal Medicine CME Meeting

Your Missouri Chapter CME meeting will offer 20.5 CME hours September 15-18 at Tan Tar A including two ABIM SEP modules: 2016 Update in Hospital Medicine and 2016 Update in Internal Medicine. Details and registration are online. Note your APRNs and PAs may also receive continuing education at this meeting at a reduced registration rate.

Missouri HPPC Update

Your chapter's Health & Public Policy Committee met monthly during the Missouri Legislative session. This year the committee's efforts were focused on PDMP (prescription drug monitoring program).

As Dr. Burns describes, a viable PDMP bill made it to the senate floor before being killed by Sen. Schaaf's amendment. The HPPC was a vocal member in the pro PDMP coalition, and we will be so again this coming session. Patience and persistence will win the day...

Looking ahead, there may be two ballot initiatives that the MO Chapter will weigh in on. We expect that the tobacco tax increase will not be significant enough to have a public health benefit so we will likely recommend opposition to this. Legalization of medical marijuana may also be put to a vote of the people. Our stance will be consistent with the ACP's stance which does not support medical marijuana statutes.

Dr. Burns also touched upon the uncertainty of MACRA and Medicare payments. The six chapter members who attended Leadership Day in DC in May heard the latest on the program but the details are still being worked out. Stay tuned!

We are grateful for the support of MO Chapter members during this past legislative session. Best wishes for a wonderful summer and hope to see you at the annual Chapter meeting in September. As always, we welcome your input.
