## Governor's Message

Greetings ACP Colleagues,

Fall has been a busy time for the College, both locally and nationally. At the chapter level, please help me congratulate Dan Goodenberger, MD, MACP, Missouri's new governor-elect designee. Dr. Goodenberger has a wealth of leadership experience which will help move our Chapter forward over the next few years. His term as governor starts in April 2019. I would like to thank Beth Andes, MD, FACP and Megan Wren, MD, FACP for their candidacy as well.

So much of the time hot-button advocacy issues tend to grab headlines, but at the national level ACP staff works just as hard on matters relevant to the practicing internist. In November, the Centers for Medicare and Medicaid Services (CMS) announced two new programs which reflect 'quiet' wins for the advocacy arm of ACP. The first, 'Patients Over Paperwork,' mirrors ACP's current initiative, 'Patients Before Paperwork.' CMS would evaluate (and then amend) existing regulations, allowing more time for physicians to spend treating patients. The second program, 'Meaningful Measures,' was created to eliminate regulatory issues deemed overly burdensome. Want to help? Your response in ACP's data collection tool ("Administrative Tasks and Best Practices Survey") can assist in providing important feedback to CMS.

I could list several more initiatives that go relatively unnoticed yet make a real difference. The 'house' of internal medicine is huge, and the challenge for ACP is to provide value for all, regardless of membership class (Student to Master), practice location (community or academic), or specialty (generalist, hospitalist or subspecialist care). If you look closely enough ACP offers SOMETHING FOR EVERYBODY, and strives to deliver innovative programs, products and services. Your membership makes all the difference! If you have ideas on how we can improve either at the chapter or national level please contact me directly.

Last but not least, on behalf of the entire Missouri membership I'd like to give a huge THANK YOU to Pat Mills, our longtime ACP Chapter Executive Director. Pat will be stepping down at the end of this year to begin his new role as Executive Vice President for the Missouri State Medical Association. To say that Pat has been the rock of our Chapter over the past two decades would be an understatement. The good news? We get an excellent replacement in Sarah Luebbert and Pat will remain available when we need to tap into his experience.
